- Represented Zhongtian Construction Group Co., Ltd. to handle a construction project contract dispute with General Electric Company of America, obtaining an award of Settlement Based on the Submitted Price before the China International Economic and Trade Arbitration Commission;

 related to Shanghai Shijihui Plaza's engineering quality, by analyzing the burden of proof and the evidence's demonstrability,
 convinced the Supreme Court not to recognize the appraisal reports submitted by the opposing party, and rejected all the opposing
 party's claims totaling 368 million yuan.
